Both Ms. Alvarez and Rev. Daniel Alvarez will be recognized with North Park University's "David Nyvall Medallion Award" for Service to the People of Chicago. They will accept the award during the university's spring commencement ceremony at North Park's Anderson Chapel on May 12th. Previous recipients include former Chicago Mayor Richard M. Daley and The Rev. C.T. Vivian, the civil rights

Under his leadership and the leadership of Ms. Alvarez, Casa Central grew from a staff of three employees and a \$26,000 budget to an acclaimed model agency with a staff of over 500 employees and a budget of approximately \$17 million.



Special Recognition for School Age Program

Our School Age Program received its own letter of accreditation from the Council on Accreditation (COA), following COA's detailed review and analysis of Casa Central's operations and practices for service delivery.

In a letter from COA President Richard Klarberg, the School Age Program was cited as an "outstanding provider" for committing to deliver high quality services. The accreditation process looks at a variety of standards for accessibility, cultural responsiveness, and other variables.

The School Age Program engages more than 60 children each school day in many educational, cultural and recreational activities after school. The program offers supervised, quality care while parents are working, attending school, or attending a training session approved by the Supplemental Nutrition Assistance Program (SNAP).

Since 2000, Casa Central has maintained agency accreditation for COA, indicative of best practice standards in all facets of operations and services.

STANDING UP support TO VIOLENCE Casa Central

This year, the week of April 15-22 was designated as "Prevent Childhood Exposure to Violence Week. "Our Violence Prevention and Intervention (VPI) program and Heartland Alliance teamed up to organize their first art contest for children, as a way of creating awareness about violence and peace.

The Safe Start component of the VPI program works with very young children, ages 5 and under, and their families, who have been exposed to violence in their homes or communities. Highly specialized interventions, such as Safe Start, are needed as early as possible for children experiencing toxic stress, so children and their families can build a safe and healthy life.

Our new annex to Casa Central will allow our VPI program to serve more clients in a safe, comfortable and confidential setting. However, added space brings additional overhead; repairs are in order for the building's HVAC system, at an estimated cost of \$18,000.
