Position Summary:

This job is responsible for transporting participants to and from the facility and during special events as requested. The driver will report any routine problems to the Transportation Coordinator immediately.

Essential Duties and Responsibilities

General Duties

All drivers are responsible to adhere by the rules of the road at all times and are responsible for completing all agency-approved training.

Safety Procedures

Responsible for ensuring the safety of the passengers through driving them safely to and from Casa Central facilities and reporting any mechanical problem to the Transportation Coordinator inspector and Director of Transportation. Drivers may be asked to work overtime, holidays, weekends or for special events.

Driver Checklist

Responsible for maintaining a checklist with the daily vehicle inspection routine, such as vehicle inspection, and mileage in & out logs.
